#### Purpose of post

Healthcare Inspectorate Wales (HIW) regulates Independent Healthcare providers and inspects NHS Services in Wales against a range of standards, policies, guidance and regulations to highlight areas requiring improvement.

You will form part of a multi-disciplinary inspection team. You will be expected to participate in meetings and interviews with key clinical and management representatives of the organisation under inspection.

HIW will utilise your knowledge and skills to ensure that our work is based on current practice and experience. This helps us to highlight good practice and to reinforce and share Healthcare Standards within both the NHS and Independent Healthcare Sector for public assurance and improved service for patients.

#### **Key tasks**

- Work with HIW under the support and direction of HIW staff.
- Travel throughout Wales to inspect the physical environment, polices / procedures, equipment, certification, patient and other records.
- Undertake interviews of staff and patients.
- Manage time effectively to ensure you are fully prepared for the inspection visit and to read pre-inspection intelligence and previous inspection reports.
- Respond to any issues of concern as appropriate in discussion with the HIW Inspection Manager.
- To make observations and recommendations based on your own clinical and professional judgement, taking into consideration clinical rationale, the interests of patients, and the implementation of any relevant Regulations and Standards.
- Make a record of your findings during the visit using the inspection tools and contribute to the feedback meeting at the end of the inspection using evidence gathered.
- Review and comment on inspection reports for accuracy prior to publication.
- Undertake shorter, focussed follow-up inspection visits (as required).
- Demonstrate respect and understanding of diversity and citizenship of staff/service users.
- Attend any induction and training deemed necessary by HIW.
- Act as an ambassador for HIW by promoting the work of the Inspectorate and sharing best practice.

#### **Job Specific Criteria**

- Currently registered with the General Medical Council (GMC).
- Current or recent (within the last three years) hands-on experience of clinical practice.
- Substantive practice experience of at least five years, in a senior capacity (with staff leadership responsibilities) within an Emergency Department .
- Evidence of continuing professional development.
- Experience and good understanding of clinical governance including effective implementation and monitoring of clinical and professional standards.
- Experience of effective risk management including effective incident reporting and complaint handling.
- High quality drafting skills.
- Demonstrable commitment to equality and diversity.
- Excellent interpersonal, communication and listening skills.
- A highly professional patient focused approach, with strong values of safe, compassionate person centred care.
- Excellent observational, assessment and analytical skills.
- Ability to work effectively on their own and as part of a team.
- Use of IT.

#### Desirable criteria

- Previous experience of inspection and / or Quality Assurance processes.
- An understanding of the objectives and priorities of HIW.

#### **Development opportunities**

Peer reviewers will gain inspection and review experience and will improve their analytical, drafting, team working and communication skills.

Working with HIW provides peer reviewers with the opportunity to take good practice back to their own work areas.

Induction and/or training days offered to peer reviewers will be allocated continuing professional development (CPD).
